


### PARTNERSHIPS OF TSUL WITH NGO AND CORPORATIONS



#### The delegation of the United States Agency for International Development (USAID) visited Tashkent State University of Law

The meeting was attended by Bakhshillo Khodjaev, Vice Rector for Research and Innovation at TSUL, Bobur Uzakov, Chief Specialist of the International Relations Department, Mamed Askerov, USAID Democracy and Governance Project Management Specialist, Faye Haselkorn, USAID Democracy and Governance Office Director, and Jamshed Luberi, USAID Executive Office Director.

The meeting discussed issues of assistance to TSUL in the process of international institutional accreditation according to QAA standards, providing financial support in attracting experts in this process, organizing training seminars and conferences, facilitating the establishment of cooperation with leading universities in the USA, Great Britain and the European Union for the implementation of double-degree programs, in particular, organizing official trips of TSUL delegations, sending teachers and staff of TSUL to these universities for internships, as well as providing financial support in the process of organizing international scientific conferences, training seminars, round tables discussions, summer and winter schools as part of internships for doctoral students, independent researchers, attracting leading professors and specialists from the United States to teach at TSUL in full-time and distance formats. An agreement was reached on the issues discussed at the meeting.



## In cooperation with the USAID Legal Reform Program, professional training courses for legal personnel on international standards are organized

Classes organized by the Center for professional training of legal personnel on international standards at Tashkent State University of Law are conducted by specialists of law firms "White and Case" (USA), "Foley Hoag" (USA), "Dentons" (USA), "36 Group" (England), Swiss Arbitration Academy (Switzerland), Academy of Law of International Financial Center "Astana" (Kazakhstan). The course will provide information about the peculiarities of international commercial and investment contracts, contractual terms in English law, negotiation, and the peculiarities of arbitration of disputes arising from the contract. About 40 specialists of the state and economic governing bodies participate in the course as listeners and the international certificates will be handed over to the course graduates.

### Tashkent State University of Law will be transformed in steps

Department of Transformation of Tashkent State University of Law started to prepare Tashkent State University of Law for the international accreditation conducted by QAA - UK Quality Assurance Agency. A series of training sessions aimed at improving the curricula (syllabuses) in line with international standards were organized in this regard with financial support from the international NGO "Regional Dialogue". The training was conducted by invited trainers-experts from Great Britain: Professor Richard Grimes (independent expert) and Professor Stephan Levet from York University Law School. The training was attended by employees of the Department of University Transformation, Department of Educational Quality Control, Educational and Methodological Department (Registrar's Office), deputy deans of faculties on academic affairs, and lecturers responsible for the academic direction of the departments. During the sessions, there were discussed the requirements of the QAA UK curriculum (syllabuses), assessment and training based on syllabuses, the impact of syllabuses, the relationship of the curriculum and syllabuses, SMART principle in determining the expected module outcomes, important aspects to pay attention to when designing an assessment.
