Center for professional training of lawyer's by international standards under Tashkent State University of Law was established on the basis of the branch center of retraining and improving qualification of pedagogical staffs under Tashkent State University of Law according to the Decree of the President of the Republic of Uzbekistan NPD-3666 on April 13, 2018 "On organizational measures for further improvement of the activity of the Ministry of Justice of the Republic of Uzbekistan".

Main objectives of Centre are:

To train juridical staff on international standards in terms of defending interests of Uzbekistan and Uzbek organizations, to create broaden measures retrain persons who has higher education in legal specialty and retrain teaching personal who conducts legal classes in the higher educational and secondary educational establishments.

Courses of retraining and improvement qualification of pedagogical staffs

In the Center, there are 288-hours courses of retraining and improvement qualification for pedagogical staff teaching in higher education institutions in law in "Jurisprudence" and "Legal science", as well as 144-hours courses of improvement qualification for secondary-specialized teachers in law in "Lawyer".

These courses aimed at continuously updating the professional skills, and abilities of pedagogical staff as well as improving the quality of training based on modern requirements.

Tashkent mediation center was established

The Tashkent Mediation Center, a non-governmental non-profit organization, was established under the auspices of the Tashkent State Law University and the Center for Professional Development of Lawyers.

The new structure brings together professional mediators engaged in alternative dispute resolution in an organizational and methodological way. The center also trains professional mediators in mediation and alternative dispute resolution.

Now, citizens and entrepreneurs can apply to the mediation center to resolve their disputes. In addition, applicants will have the opportunity to find a solution to their disputes by choosing a mediator who is an expert on the issue raised.

Admission requirements

Applicants are required to hold a PhD degree in law, have at least h-1 index in Scopus abstract and citation database and have published articles in Scopus or Web of Science indexed journals.

For an application to be considered, applicants must submit a curriculum vitae proving meaningful professional and/or academic activities.
